MBA Program Requirements

The MBA degree prepares professionals to lead and manage organizations with skills in operations, finance, accounting, economics and strategic management.

Prerequisite Courses:

Students are required to demonstrate successful completion of the following undergraduate courses:

- 6 credits in Accounting
- 3 credits in Economics
- Quantitative Analysis; and Calculus or Statistics (6 credits)

Prerequisite course equivalencies may be demonstrated by one or more of the following methods:

- (1) Official undergraduate transcript from an accredited institution demonstrating successful completion of the prerequisite courses
- (2) CLEP examination results demonstrating proficiency in the prerequisite courses

Admission Requirements

Individuals with a bachelor's degree in any undergraduate major from a regionally accredited college or university (or an equivalent degree from an accredited institution outside of the United States) may apply to this program.

Application materials are submitted online at salve.edu/grad. There is no fee to apply. Salve Regina University evaluates the total application package; you must submit the following to be considered:

- Completed graduate application
- Official transcripts from each college/university attended
- Personal statement
- Resume

Concentrations

Cybersecurity Issues in Business

The concentration in cybersecurity issues in business addresses the cyber threats that face many organizations. Awareness of threats and managing risks work to decrease vulnerabilities and exposure that left unchecked, may damage an organization's brand, credibility and value.

Entrepreneurship

This concentration is designed to develop creative thinking, opportunity analysis and support, business plan development, and strategic planning.

Finance

The concentration in finance emphasizes the knowledge and analytical tools necessary to inform prudent financial decisions that improve business value and investment performance.
